## Non-Exclusive Diamond Lease

This License Agreement is made on $\qquad$ ("Effective Date"), by and between $\qquad$ (referred to as the "Licensee") also, if applicable, professionally known as $\qquad$ , and _Barbara Rodriguez , (referred to as the "Licensor") also, if applicable, professionally known as $\qquad$ Babi $\qquad$ . The Licensor warrants that it controls the mechanical rights in and to the copyrighted musical works entitled $\qquad$ ("Composition") as of and prior to the Effective Date. The Composition, including the music, was composed by $\qquad$ ("Songwriter") managed under the Licensor.

The Licensee and Licensor have agreed to the following terms:

1. Master Use. The Licensor hereby grants to Licensee a exclusive license (this "License") to record vocal synchronization to the Composition partly or in its entirety and substantially in its original form ("Master Recording").The Licensor guarantees that the Composition will not be sold on to any third parties.

## 2. Production Rights.

A. Copyrights. The Licensor maintains full ownership of the Composition. The Licensee may not loan, rent, or resell the Composition. Following the execution of this agreement, the Licensor may continue to transfer or license any or all rights of the Composition to other parties for any purpose, exclusively or non-exclusively. Previous licensees of the Composition will retain their license rights in full as per Licensor agreement with them.
B. Mechanical Rights. The Licensor hereby grants to the Licensee permit to use Master Recording in the reproduction, duplication, manufacture, and distribution of phonograph records, cassette tapes, compact disk, digital downloads, other miscellaneous audio and digital recordings, and any lifts and versions thereof
(collectively, the "Recordings", and individually, a "Recording") worldwide to pressing or selling unlimited copies of such Recordings or any combination of such Recordings.
C. Performance Rights. The Licensor hereby grants to Licensee permit to use the Master Recording in unlimited non-profit and/or paid performances, shows, or concerts.
D. Synchronization Rights. The Licensor hereby grants to Licensee permit to copy, perform, edit and/or loop portions of the Composition, record on film, video, digital animations, and video games (collectively, "Projects") and use the Master Recording in synchronization or timed relation with the productions in unlimited Projects. The Licensor shall be acknowledged as a Writer or Music Producer, by the following PRO information 00359953113 and shall receive $50 \%$ of sync royalties.
E. Broadcast Rights. The Licensor hereby grants to Licensee permit to broadcast or air the Master Recording on an unlimited number of radio stations.
3. Credits. Licensee shall acknowledge the original authorship of the Composition appropriately and reasonably in all media and performance formats under the name of the Songwriter in writing where possible and vocally otherwise. Where a project is commercially released and registered with a performance rights organization, the Songwriter or Licensor, whatever is the case, shall be acknowledged as a Writer or Music Producer, by the following PRO information 00359953113.
4. Sampling. The Licensee agrees that the Composition is purchased as a "Work Made for Hire" whereby the clearing of any sampled materials is the responsibility of Licensee.
5. Delivery of files. The Composition shall be delivered via email to an email address that Licensee provided to Licensor. Licensee shall receive an email containing the MP3, WAV and masters files from the Composition.
6. Indemnification. Accordingly, Licensee agrees to indemnify and hold Licensor harmless from and against any and all claims, losses, damages, costs, expenses, including, without limitation, reasonable attorney's fees, arising of or resulting from a claimed breach of any of Licensee's representations, warranties or agreements hereunder.
7. Royalty Splits. The Licensee owns $50 \%$ of the "Writer's Share" as music artist and/ or songwriter. The Licensor owns $50 \%$ of "Writer's Share" as music producer and/or songwriter. The Licensee owns 50\% of "Publishing Rights" as music artist and/or
songwriter. The Licensor owns 50\% of "Publishing Rights" as music producer and/or songwriter.

## 8. In Consideration.

A. In consideration for the rights granted under this agreement, Licensee shall pay to Licensor the sum of $\$ 200$ US dollars and other good and valuable consideration, payable to the Licensor, receipt of which is hereby acknowledged. The payment for this License is non-refundable. If the Licensee fails to account to the Licensor, timely complete the payments provided for hereunder, or perform its other obligations hereunder, including having insufficient bank balance, the Licensor shall have the right to terminate License upon written notice to the Licensee. Such termination shall render the recording, manufacture and/or distribution of Recordings for which money have not been paid subject to and actionable infringements under applicable law, including, without limitation, the United States Copyright Act, as amended.
B. This license is non-transferable and is limited to the Composition specified before. This constitutes the entire agreement between the Licensor and the Licensee relating to the Composition, and shall be binding upon both the Licensor and the Licensee and their respective successors, assigns, and legal representatives.
C. Executed by the Licensor and the Licensee, this License agreement is to be effective as for all purposes as of the Effective Date and shall not expire.
9. Governing Law. This License is governed by and shall be construed under the law of the State of FL, United States of America, without regard to the conflicts of laws principles thereof.
